STATUTORY DECLARATION

I, Peter Morgan of Walshes Manor, Walshes Road, CROWBOROUGH, East Sussex, TN6 3RB, England, solemnly and sincerely DECLARE as follows:

- 1. My name is Peter Morgan. I am 69 years old and a British citizen. I have been performing religious duties at the Church of Scientology at Saint Hill since 10th January 1972. Before this, I was training to be a Dianetics counsellor in Sydney for the 2 years prior to my arrival at Saint Hill. My current position is that of Senior Chaplain at the Church in Saint Hill, East Grinstead, West Sussex, RH19 4JY.
- I am a fully ordained Minister of the Church and have been since 1973. I am also well versed in Church Policy as it relates to the training of Scientology Auditors and the running (Administration) of the Church in all its aspects, being a graduate of the Organization Executive Course and the Flag Executive Briefing Course, the latter being the top course in Administration.
- 3. One of my first positions with the Church, from about April 1972 onward, was that of Registrar, a position which gave me the opportunity, along with two other Registrars, to meet everyone who arrived to Saint Hill from all over the world. Among those whom I had the pleasure to meet, was David Miscavige who came here to train as an Auditor (Dianetics & Scientology Counsellors) and also to receive counselling.
- 4. Being a Registrar, it was part of my function and responsibility to see that those whom I had registered for course (or counselling), were progressing through their courses and that they were achieving success with the application of the data which they had been learning. One of the things about such courses is that one is expected to apply what one is gradiently learning, and one is expected to undergo a period of Internship (practical application) once the course or courses are complete so as to achieve permanent certification. It was while David Miscavige was here at Saint Hill that I got to know him quite well. Even more so because I received auditing from him as one of his PCs, as staff often do from Students or interns. David had completed his Academy training towards the end of March 1973 and subsequently went on to his Internship.

- 5. I particularly remember David Miscavige for two reasons. Firstly, here was this small, 13/14 year old boy holding his own with adults, who were twice his age. And like the others who trained here, his purpose was to help people. Secondly, David audited me intensively from the middle of May through to late June 1973. This was over a period of 5 weeks. I recall this auditing as having been very pleasurable and I had excellent gains from this. I always smile when I look back on this because I remember how happy I was at this time and David, my auditor, was always ready with a big smile when I came to session. We often shared a joke. I remember that there was a boomerang hanging on the wall in the room where we audited and we shared some joke about this as I had lived in Australia for a number of years. I always find that it brings a smile to my face when I look back. And although I knew from my duties as a Registrar, that he was a very intelligent and studious person and took his studies earnestly. He was, with me, always light and very friendly. Definitely a good auditor from my perspective, and I know this as I was always smiling and happy at the end of my sessions. And this is one of the ingredients of being a good auditor per L. Ron Hubbard
- 6. Back in those days, (early 70's) Saint Hill was a tight-knit community, meaning almost everyone knew what everyone else was doing and how they were getting along, (aside from the fact that it was my job to know). That's because everyone communicated a lot; at lunch and afternoon and dinner breaks. Everyone knew everyone else.
- 7. I personally have no recollection of David having any problems with his training whilst here at Saint Hill as any violation of the Policy, "Students Guide to Acceptable Behaviour" would have come to my attention. I never heard of David being physical with anyone. I would definitely have heard about this, as I was the Registrar.
- 8. I observed and heard only good reports about David. He was well-liked by staff and students. I admired him because most of the students of this subject were from my recall, around 25 35 year old men and women, a number of whom were very well educated.
- 9. I have seen Mr. Miscavige many times since he left Saint Hill and joined the Sea Org. In fact, he comes to Saint Hill every year. He always remembers me and I him, we shake hands and exchange pleasantries. I recall one time a few years ago when he came into the Registrar's office where I was speaking with the Chief Registrar, Hazel Grafton (whom he also knows well from his time here as a student) and he just looked at both of us, smiled and said, "Deja vu!" We all found this amusing.
